Item 3.02 Unregistered Sale of Equity Securities.

On September 1, 2009, Rand Capital Corporation sold 733,315 common shares, par value \$.10 per share issued by it ("Shares"), and on September 4, 2009 it sold an additional 8,287 Shares, with an aggregate price of \$ 2,536,279, or \$3.42 per Share. These sales completed the sales under an offering of up to 1,100,000 Shares commenced on July 24, 2009. No underwriting discounts or commissions were paid in connection with the sales. The Shares sold in the offering were sold in a private offering under the exemption from registration under section 4(2) of the Securities Act of 1933 and Rule 506 under the Securities Act. The Shares were sold in the offering exclusively to "accredited investors" as defined under Rule 501 without the use of any general solicitation or general advertising, and the sales were made subject to the limitations on resale provided for in Rule 502(d).
